COLLECTION OF YOUR PERSONAL INFORMATION

Katy Insurance Solutions collects personally identifiable information, such as your email address, name, home or work address or telephone number. Katy Insurance Solutions also collects anonymous Katy Insurance Solutions graphic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Katy Insurance Solutions. USE OF YOUR PERSONAL INFORMATION

Katy Insurance Solutions collects and uses your personal information to operate the Katy Insurance Solutions Web site and deliver the services you have requested. Katy Insurance Solutions also uses your personally identifiable information to inform you of other products or services available from Katy Insurance Solutions and its affiliates. Katy Insurance Solutions may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Katy Insurance Solutions does not sell, rent or lease its customer lists to third parties. Katy Insurance Solutions may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. USE OF COOKIES
